ARIS Enterprise – Admin	
Schedule service release upgrades within ARIS and ARIS Process Mining	In ARIS Enterprise SaaS, Server Administrators can now schedule upgrades for their environments in ARIS. Server Administrators can check and immediately book available time slots, increasing the efficiency of the upgrade process.
ARIS Enterprise - Designer	
New ARIS Repository search: add columns for sorting	ARIS Designers and Admins can maintain content more easily using the ARIS model repository search. As a Designer or Admin you can now add additional property columns to the table of the search result, order these columns, and sort the table based on column values.
ARIS Enterprise – Server/Enterprise Server	
Subfolders in ARIS Document Storage automatically take the privileges of the parent folder	A newly added folder in the ARIS Document Storage will automatically take the privileges of the parent folder.
ARIS Enterprise - Viewer	
Mandatory attribute/content checks at fact sheet	The WYSIWYG editor has the option to always show (or hide) empty properties to end users. This can be used to show mandatory attributes to end users.
Update confirmation panel to fit new fact sheet redesigns	Updated and redesigned confirmation panel to sign off that you have read and understood the newly published content(s) in order to fit the new content overview pages in the portal.
New Portal search: Make it the new standard (after pilot phase)	All consumers of content have a new search UI which finds relevant content across all published ARIS sources, including related and unrelated documents that they have access to. No longer need to interpret why something was found and what it is.
SSC portal configuration with WYSIWYG approach	The new and redesigned experience of consuming content in the portal features an intuitive drag & drop editor. You can either use it to adjust the pre-configured overview fact sheets or to create new content overviews in a visual manner.
Add "Clickable" option to first column of Tables for Self-Service.	Using WYSIWYG editor you may now easily activate or deactivate if a property or the first column of the table is clickable or not. Also, we changed the standard behaviour for the first column of the table to avoid opening object factsheets unintentionally.
Update/consolidate all fact sheets to new design	ARIS offers redesigned content overviews (overview fact sheets) with a fresh look and feel, and with improved navigation patterns.
New Repository Search field must not depend on portal customizing	Fixes the problem that the new Repository Search disappeared when activating the new Portal Search for an environment with portal customizing. The new Portal Search now resides in the Global Configuration.

ARIS Enterprise - Viewer Pro	
Show thresholds/ max/ min/ avg/ totals as lines in a chart	Show calculated fields like thresholds, minimum, maximum on the chart for clutter-free visualization.
Chart visualization for redesigned fact sheets (React)	Improve the dashboard widgets to accommodate the new redesigned fact sheets and smaller sizes in WYSIWYG editor.

	For databases containing a large number of models and objects, the number of items available via API access is no longer limited to 5,000.
Increased number of result items for ARIS Rest API	Maximum number of model items will be increased to 10,000 (and page size from 500 to 1,000).
	Maximum number of object items will be increased to 100,000 (and page size from 500 to 10,000).
ARIS Enterprise – Extension: I	Risk & Compliance
Issue Management – ARIS suite integration	Improved integration of Issue Management into the ARIS Portal, potentially addressing all ARIS user types without requiring navigation into specific Risk and Compliance extension-based pages. This will improve acceptance and user journeys.
ARIS Risk & Compliance Management now supports multi-tenancy	The ARIS Risk & Compliance extension can now be used in multi-tenancy scenarios. This is key for further usage in Saas/Cloud and shared environments. This also includes confirmation management.
Enable adding workflow-object lists to portal items	Risk and Compliance-relevant operational items (including control tests, surveys and incidents) are made available in the ARIS Portal for ARIS users having the respective GRC role (manager, auditor) without the need to navigate via a long click path. This will make the user journey less complex and supports the integrated impression for 1st line of defense being at the same timeline of business.
Import control execution documentation via API	Documentation of control executions can come from external IT systems and does not necessarily need human interaction. To support this, an API-based import is offered to fill in that information into the Risk and Compliance extension automatically.
ARIS Enterprise – Extension: I	Robotic Process Automation (RPA)
New performance enhancements for ARIS task mining/Robotic Process Discovery	A deployment of Process Discovery can now support 300 simultaneous bots with a total of 5,000 user actions in an 8-hour period. Added support for Windows 11. Added support for .NET 6 in the PDDR.
New features and improvements for ARIS RPA	ARIS RPA brings new features and improvements to the security, stability, and performance of the RPA platform. This includes a newly introduced API as well as an increased number of bots that can be maintained by one server.
ARIS App Generator	
Enhancements for ARIS App Generator	Multiple maturity features added to the ARIS APP Generator, including enhanced technica documentation as well as an installer that simplifies the installation of the App Generator to an existing ARIS Enterprise on-prem installation. In addition, some improvements of managing Excel tasks, especially formula calculation, multi-files management and writing to a template have been added.
