

#### User


This configuration is to setup the Users (internal and external) in MFT system – The user can be an enterprise application or an external Vendor


#### **Events & Action**

These are the inbound and outbound actions which can be either Scheduled or Post-processing based. The most common actions are Copy, Archive, encode/decode and Move.




### **Conventional MFT Development**
